Dear Parents and Community Members:

We are pleased to present you with the Annual Education Report (AER) which provides key information on the 2020-21 educational progress for the Sparta High School. The AER addresses the complex reporting information required by federal and state laws. The school's report contains information about student assessment, accountability, and teacher quality. For the 2020-21 year, no new Priority or Focus schools were named; some Priority or Focus schools did exit their status because they met the exit criteria. New Reward schools were identified using school rankings and Beating the Odds information. A Focus school is one that has a large achievement gap between the highest and lowest achieving 30% of schools. A Priority school is one whose achievement and growth is in the lowest 5% of all schools in the state. A Reward school is one that has achieved one or more of the following distinctions: top 5% of schools on the Top-to-Bottom School Rankings, top 5% of schools making the greatest gains in achievement (improvement metric), or "Beating the Odds" by outperforming the school's predicted ranking and/or similar schools. Some schools are not identified with any of these labels. In these cases no label is given. Our school has not been given a label.

Sparta High School continues to identify gaps in achievement, and pursues research-based strategies designed to close those gaps. Achievement gaps exist most noticeably within our Special Education and English Language Learner (ELL) populations. Sparta High School continues to use the Gradual Release of Responsibility as our instructional model. Sparta High School is a Professional Learning Community that strives for embedded Professional Development opportunities for our staff based on our students' achievement and growth data. In addition, Sparta High School took the following measures designed to close the achievement gap:

Restructured our intervention process to include content area experts as well as ELL staffing to provide individualized instruction for our at risk students during their normal school day in both push in and pull out formats

Implemented a new process for FOCUS to identify students who are struggling and support them in creating learning goals

Added after school intervention for targeted at risk students

Create Math Specific Focus classes for additional, teacher provided math support and instruction

Began implementation of NWEA testing for 9th grade students in order to more specifically identify their areas of need
